I understand that I have been advised to consult a physician prior to commencement of my weight and/or cardio training program to ensure my state of wellness to participate in such strenuous activities. Furthermore, I understand my trainer does not hold him/herself out to be a licensed physician.

I understand that I may suffer bodily injury, and/or death, and/or loss of property, and I acknowledge that serious accidents may occur during activities which I may participate in, including Jiu Jitsu, Grappling, Wrestling, Boxing, Sparring, Fighting, Aerobic exercise, weight training, and all activities of sport, Martial Arts or non-related activities taking place in connection with Candal's Martial Arts & Brazilian Jiu Jitsu Academy, and I assume all risk as a participant and/or spectator, and/or bystander.

I, the Client, hereby release and hold Instructor and Candal's Martial Arts & Brazilian Jiu Jitsu Academy harmless from all actions, claims, or demands that I, my assignees, heirs, distributes, guardians, and legal representative(s) now have or may hereafter have for injury or damage resulting from my participation in a martial arts, weight and/or martial arts training program. Program Rules and Regulation

It is very important that you understand each of the following rules of Candal's Martial Arts & Brazilian Jiu Jitsu Academy. Please do not hesitate to ask any questions. Your initials on the line next to each rule and your signature at the bottom are required. Thank you for joining Candal's Martial Arts & Brazilian Jiu Jitsu Academy!

_____ I understand that the program I am enrolling into is a commitment and I am obligated to make the payments for the time indicated on the agreement. This program will not be canceled, and if paid in full, will not be refunded. The regular tuition is \$25 per class, but a substantial discount has been provided by enrolling in a regular training program.

_____ I understand that my monthly payments will be automatically drafted at no extra charge on a monthly basis through my credit/debit card or checking account by Candal's Martial Arts & Brazilian Jiu Jitsu Academy or PC, a billing company use by Candal's Martial Arts & Brazilian Jiu Jitsu Academy. If my payments are late, I will be subject to a late fee determined by number of days late.

_____ I understand that once the period of time of the contract has been completed, I will be billed month-to-month. In order to cancel, I must provide a 30-day written notice. If not, I will continue to be billed on a month-to-month basis.

_____ I understand that there is a belt testing fee for each student, due prior to testing for a new belt, when they reach the minimum required classes per belt to test. This fee includes the testing, belt, and certification. All students are required to test upon receiving a "testing invitation." It is not the family or student's decision to test or not, solely the instructor's.

_____ If students do not attend required belt events, they may not be able to be promoted to a new belt rank.

_____ I understand that there is a certain required equipment that must be purchased for use in class. Because of insurance requirements, all equipment must be purchased at Candal's Martial Arts & Brazilian Jiu Jitsu Academy to ensure formality, high standards, and safety due to faulty or low quality equipment. Students will not be allowed to participate in class if he/she does not have the required equipment. Due to sanitary reasons, the school will not be allowed to loan equipment.

_____ I understand that all students must be on time for class. If late, students may be required to do squats, jumping jacks, or some form of exercise. This is not a punishment; rather they will benefit the student as a warm up. If students are late more than 15 minutes, students may not be allowed to enter class. This rule may be excused due to weather, extreme circumstances, or prior phone call.

_____ I understand that as a student of Candal's Martial Arts & Brazilian Jiu Jitsu Academy, I will not train at any other Jiu Jitsu school or with other black belt instructors without prior authorizations from Master Victor Candal. Also, students may not participate in tournaments outside of the school without prior approval from Master Victor Candal.

Please read this document in it entirety, and fully understanding that if I do not comply with the above rules and regulations, Candal's Martial Arts & Brazilian Jiu Jitsu Academy may suspend or terminate my training program with no refund.
